## Our Mission: Justice for All

Each year, thousands of people request legal help from Advocates for Basic Legal Equality, Inc. (ABLE), Legal Aid of Western Ohio, Inc. ## The Campaign

The Justice for All Campaign is a fundraising partnership among LAWO, the TBA Pro Bono Legal Services Program, and ABLE. As the sole providers of free civil legal aid to low-income residents of northwest Ohio, the Justice for All Campaign unites our fundraising efforts to ensure that vulnerable and disenfranchised members of our community have equal access to the legal system.

Why is our work in providing equal access to justice so important? Our advocates provide free civil legal services to help clients find legal solutions to their desperate circumstances. Last year, we helped thousands of individuals and families in matters of housing and eviction defense, immigration, elder law, community and economic development, domestic violence, family law, trafficking, and benefits assistance. Without our assistance, most would go without legal representation.
